Keuring and Equine Care Code of Conduct

Should the soundness, health or behaviour of a participating horse be questioned, the Organisers, after consultation with the person responsible for the horse and an official veterinarian if necessary, shall make the decision as to whether the horse may continue to participate.

The Organisers decision shall be final.

- 1. The welfare of the horse is paramount and shall be considered above the demands of breeders, trainers, riders, drivers, owners, organisers, sponsors and officials.
- 2. The highest standards of nutrition, health, sanitation and safety of the horse shall be encouraged and maintained at all times during the 2025 keuring.
 - 3. Riding, driving, handling and training methods shall not include any technique which might be considered abusive to the horse.
- 4. Adequate provision must be made for maintaining a healthy and safe environment for the transport and stabling of horses to and from the 2025 keuring.
- 5. If a horse poses a threat to any attendees, organisers or other participants of the event, the keuring organiser will have the right to remove the horse from the area.



RELEASE OF WAIVER OF LIABILITY AND DANGEROUS ACTIVITY ACKNOWLEDGEMENT

HORSE SPORTS ARE A DANGEROUS ACTIVITY

In consideration for being permitted to participate in any way in horse sport activities, l, the undersigned understand, acknowledge and accept that horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt. There is a significant risk that serious INJURY or DEATH may result from horse sport activities.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Australian Friesian Horse Society Incorporated and I voluntarily participate at my OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities or any other AFHS Inc. activity.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind-altering drugs before and during any AFHS Inc. organised activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during any horse sport activity.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the CANCELLATION of my participation in any event and my immediate removal from my horse NO MATTER where that may occur.

I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the AFHS Inc. against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times during ridden horse sport activities and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times and take sole responsibility for my actions.

I agree not to sue the AFHS Inc. (including their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsors, and if applicable, owners and lessors of premises used to conduct the events) with respect to ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE AFHS Inc. OR OTHERWISE. Effect of this Document

I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by agreeing to it, & agree with it



freely and voluntarily without inducement of any kind.

I understand that the signing of this waiver constitutes a complete and unconditional release of all liability to the AFHS Inc. to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.
